

MT/WY Kinship Programs

Montana

- Founded in 2002
 - Was a statewide service to kinship caregivers
 - Support, education, and access to resources for kin caregivers
- House at Montana State University
- Program developed by Sandy Bailey to meet needs of grandparents raising grandchildren
- 2000 Census reported 6000+ grandparents were raising their grandchildren

Wyoming

- Founded in 2019
 - Was piloted in Laramie and Natrona Counties with the intent to go stateside in 2 – 3 years
 - Support, access to resources, and case management for kin caregivers
- Lead & Fiscal Agent Wyoming 2-1-1
- Program is modeled after the Kinship Navigator Program – Arizona to meet the needs of grandparents raising grandchildren
- 2010 Census reported 5000+ grandparents were raising their grandchildren

Services Program

Kinship Connections of Wyoming and the Montana Kinship Program serve all kinship families regardless of their involvement with the child welfare system or their income level.




