The Network hosts webinars and facilitates learning collaboratives.




#### **Individual Assistance**

### Follow Evidence-Based Model with Fidelity

- Title IV-E child welfare agencies that want to follow one of evidence-based models that are in the Title IV-E Prevention Services Clearinghouse with fidelity rather than evaluate their own program can follow the guidance in <u>ACYF-CB-PI-18-11</u> to submit a <u>Title IV-E Plan Pre-Print Attachment</u> XII and revise their cost allocation plan.
- Once the attachment has been approved by the Children's Bureau and the jurisdiction's cost allocation plan has been modified and approved, 50% of all allowable program, administrative, and training expenditures for the title IV-E kinship navigator program are federally reimbursable.



### Title IV-B Competitive Opportunity

- \$10 million in new competitive FY 2026 grants for kinship navigator programs
- Notice of Funding Opportunity (NOFO) expected around May 2026, with Grant Forecast sooner
- Nonprofits or universities can be lead applicants
- Any nonprofit or university lead applicant should closely collaborate with their jurisdiction's title IV-E child welfare agency
- NOFO expected to require naming an evidence-based model to follow

Washington State Kinship Navigator Case Management Model



## **Essential Program Components**

- → Kinship Care Oversight Committee (KCOC) includes caregivers, youth, coalition leaders, and local kin organizations to provide ongoing feedback
- → Train navigators, staff and partners on the needs of kinship families to promote better services and support

- → Website
- → 211 coordination warm line/call in support
- → Distribution of brochures and community presentations

Program advertising Information Program and assistance oversight (I&A)

→ Caregivers in comparison sites received I&A services, whereby navigators provide information and referrals to services

→ Legal services, Kinship 101, etc.

Caregiver education Caregivers & children

Needs assessment → Pilot caregivers received a comprehensive needs assessment to identify needed services and supports

Peer to peer support

Case management services

Urgent funds

→ Pilot caregivers were referred to case management, which included goal setting and regular followups

→ Peer navigators

→ Support groups (online or in person)

→ Designate funds to respond to needs

# **Essential Program Components**

The KIN-TECH<sup>TM</sup> integrated the kinship support model with three unique innovations

- 1) Shoulder to Shoulder Public Benefit Application
- 2) Peer-to-Peer Navigation
- 3) Interdisciplinary Team





### **Outcomes Measured**

- Improved safety and permanency at 12, 24, and 36 months follow-up
- Improved caregiver well-being
- Improved protective factors
- Improved application and enrollment of financial benefits and resources
- Increase in percentage of children's first placement with relatives





# **Examples of Program Add-Ons**

#### Kin As Teachers- (K.A.T. 2.0) An Early Childhood Intervention for Kin

- KAT 2.0 can improve child developmental outcomes and the safety of the family environment for kinship families.
- The second iteration of an adapted evidence-based program (Parents as Teachers) specifically designed for kinship families with children aged birth to five years of age.
- The Kin As Teachers 2.0 Program can be mounted on kinship navigator framework to provide developmental specialization to ensure that children living in kinship families achieve their developmental milestones.

#### **Time For Me**

- Development, Dissemination and Deployment of A Community Partnership Driven Self Compassion and Care Toolkit for Kinship Navigator Evidence Based Practice.
- This self compassion and self care toolkit is focused on improving knowledge and practice of healthy behaviors.


# Foster Kinship Navigator Program – Nevada



# **Essential Program Components**

**Evidenced-based**, trauma-informed support services

> Foster Kinship provides comprehensive support services informed by best practices and trauma-informed principles.



Foster Kinship's model focuses on peer professionals who have lived experience in kinship care and/or child welfare to provide personalized guidance and support.



Goal: Legal, financial, emotional, and parenting stability

The ultimate aim of Foster Kinship's navigator model is to help kinship caregivers achieve holistic stability and well-being in their caregiving role.


Foster Kinship's navigator model is an evidence-based, trauma-informed program that helps kinship caregivers achieve legal, financial, emotional, and parenting stability, increasing access to resources and reducing disruptions from kinship placements into traditional foster care.







### Accurate Information at the Right Time



#### Less bureaucratic friction

Caregiver expend fewer hours and less emotional bandwith chasing information

### Lower stress and higher self-efficacy

Caregivers have more psychological "room" to focus on parenting rather than paperwork

# Greater service uptake and timely financial supports

Raise household resources (e.g. TANF, KinGAP, childcare subsidy, SNAP, Medicaid, legal guardianship assistance)

### Improved household stability

Bills paid, connected to resources, and a calmer home environment - all factors strongly associated with lower placement disruption rates







Types of Support	Services	Outputs (KPIs)
Informational	Helpline, website, resource locator tool (RLT), resource center, provide basic information on kinship family types and the corresponding legal options, financial support options, and referrals to internal and community resources.	# of Helpline calls, RLTs provided, cases opened, website usage
Instrumental - Tangible	Notary, copy services, mailing service, filing services, vital records payments, basic needs (as available) like clothing, car seats, beds, formula, diapers, and safety items.	# of notary service, filing service, vital records payments, basic needs items provided, safety items provided
Instrumental - Technical	Case management gaining legal capacity, accessing financial support, navigating systems, and complex emotional needs.	# of legal sessions, financial sessions
Emotional	1:1 peer support, support groups, trauma-informed trainings, and behavioral workshops.	1:1 support provided, family events attended, support group attendees







### **Outcomes Measured**

#### **Short-Term Outcomes**

# %age of caregiver's who meet their case plan goals\*:

Legal - 80%
Financial 80%
Community Connection - 90%
Emotional Support - 90%
\*baseline for fidelity

#### Measured by:

Case plan & activity data.

Two independent quasi-experimental studies confirmed the Foster Kinship's Navigator model impact.

Compared to similar caregivers who did not receive Foster Kinship services, those who did were:

- 3.4x more likely to become licensed foster caregivers
- 1.71x more likely to receive Child-Only TANF financial support
- 2.99x less likely to experience a placement disruption

The Result: Stronger families, better outcomes for children, and significant cost savings for the child welfare system.

#### **Estimating Costs**

- **Staffing:** approx. five full-time positions for every 1,000 new families served annually
- **Direct costs:** Printing, mailing, notary for clients
- Overhead: Rent, office equipment, computer, phone

Foster Kinship in NV serves around 6,000 children per year at about \$500/per child.





# **Examples of Program Add-Ons Core Components**

### Foster Kinship works closely with the implementing jurisdiction to provide:

- Mapping Assessment of Jurisdiction Resources
- Creation of Kinship Client Profiles for the Resource Location Tool
- Data tracking tools (Salesforce optional)
- Resource Locator Tool for the Jurisdiction
- Cloud-based Jurisdiction Toolkit based on mapping assessment (including all relevant applications, referral forms, process, and resources tied to local resources)
- Roadmap for Formal Kinship Caregivers
- Diversion Guide for Jurisdiction
- Basic Video Library (CW Info Sessions, Legal Options, Financial Options)
- Pre-Screens for legal and financial resources for the jurisdiction
- Updated Kinship Navigator manual for the jurisdiction
- 80 Hours of implementing non-profit (s) staff training, technical support, and coaching


